A complete set of Bidding Documents in English language may be purchased by interested bidders on submission of a written application to the Deputy Commissioner, Department of Agrarian Development, Vavuniya from 30.01.2025 until 28.02.2025 from 09.00 a.m. to 02.30 p.m. upon payment of a non-refundable fee mentioned above. The method of payment should be by cash.
- 8. Bids must be delivered to The Chairman, District Procurement Committees, Department of Agrarian Development, Vavuniya by registered post or Directly put into the Tender Box at or before 2.00 p.m. on 03.03.2025. Name of work and Contract number should be mentioned on the left-hand corner of Envelope. Original and copy of Bid have to be submitted in separate Envelopes. Please Note that electronic bids shall not be accepted. Late Bids will be rejected. Bids will be opened soon after closing in the presence of the bidders or bidders' representatives who choose to attend.
- All Bids shall be accompanied by a Bid Security in the form of Bid Security included in Section 9. The amount and validity of Bid Security shall be as per the information given in the table above.
- 10. A Pre-Bid meeting will be held at the Department of Agrarian Development, Vavuniya on 17.02.2025 at 2.00 p.m. Presence is not mandatory, but interested bidders are encouraged to attend. Bidders should arrange their own site visit prior to the pre-Bid meeting.
